Summary of the Partnership Agreement for Bulgaria, 2014-2020

The Partnership Agreement is the national strategic document outlining the framework for the management of EU structural and investment funds in Bulgaria in the programming period 2014-2020. It covers support from five funds - European Regional Development Fund (ERDF), the European Social Fund (ESF), the Cohesion Fund, the European Agricultural Fund for Rural Development (EAFRD) and the European Maritime and Fisheries Fund (EMFF) – which together are referred to as the European Structural and Investment Funds (ESIF) - and the specific allocation to the Youth Employment Initiative in Bulgaria.

The Partnership Agreement identifies four strategic mutually reinforcing priorities through which the country will implement the EU Cohesion Policy in line with the Europe 2020 strategy for inclusive, smart and sustainable growth, namely:

- Education, employment, social inclusion and healthcare for inclusive growth;
- Scientific research, innovation and investment for smart growth;
- Connectivity and green economy for sustainable growth;
- Good governance and access to quality administrative services.

The funding priorities are based on analyses of regional disparities, development needs and the potential for growth of Bulgaria. Investments should achieve tangible, long-term results, mobilising additional national resources and private capital to create jobs in value-added sectors and promote sustainable economic growth. The identified areas of interventions are based on strategic documents outlining the policies for development of Bulgaria in the coming years, the National Development Programme, National Reform Programme, National Spatial Development Concept, as well as the European Council Recommendations for Bulgaria. Bulgaria has chosen to finance investments under all 11 thematic objectives defined in the Regulations. Details on thematic objectives are presented in Table 1.

Increasing the employment rate and ensuring high quality of the human capital through better education, raising qualifications and skills, improving health and healthcare are key priorities for Bulgaria. Special emphasis is placed on employment of youths and elderly people and on the disadvantaged groups of the population. The funds will finance initiatives to improve education and training systems and to reduce the share of early school leavers, especially among the marginalized groups in Bulgarian society, such as Roma. Social inclusion will be supported through integrated measures, which combine improvement of housing conditions with access to employment, education, social and health services.

Promoting innovation friendly business environment by enhancing the knowledge-based competitiveness of SMEs is another main priority for Bulgaria. ESIF will support

innovation activities of enterprises and innovative start-ups, developing partnerships between business and academia and improving innovation and research infrastructure. Access to funding for innovative SMEs, particularly those developing business activities in the area of low-carbon economy, is of great importance. ESIF investments are to improve energy efficiency in households, industry, services and transport alike.

A substantial share of ESIF will be devoted to upgrading Bulgaria's transport and environment infrastructure. Through modernisation and construction of missing railway and road sections along the TEN-T network, a more efficient connectivity across regions, as well as with neighbouring countries will improve the access to services and provide possibilities for development of trade and tourism. Investments are foreseen for improvement of water and waste management systems, as well as for preservation of natural resources, biodiversity and climate change risk prevention.

One of the main challenges for Bulgaria is the development and implementation of the "good governance" concept, which includes e-governance and e-justice, quality and effective services for citizens and businesses and measures for increasing the professional and motivation level of human resources in the administration and the judiciary. Therefore, funds will be spent for improving the quality and access to administrative services, reducing the administrative burden, introducing tools and procedures for monitoring and assessment of public policies, management and development of human resources in administration, etc.

The European Agricultural Fund for Rural Development aims at enhancing the competitiveness and environmental performance of the Bulgarian agri-food sector, reducing poverty and economic downturn in rural areas, and reducing the depopulation trend by preserving agricultural employment and generation of employment outside the agricultural sector.

The European Maritime and Fisheries Fund will contribute to the Common Fisheries Policy objectives for sustainable development by supporting investments and innovation that will reduce the negative impact of fishing activities on the marine environment, support SMEs of the aquaculture and processing sector, and contribute to the development of the local economy of areas dependent on fisheries through Community-led Local Development.

In addition to identifying the strategic priorities, the Partnership Agreement contains a description of the mechanisms that will be applied to ensure the effectiveness of the ESIF, as well as a description of the integrated territorial development approaches which will be applied to their management.

Results to be achieved at the end of the programming period 2014-2020

ESI funds will assist Bulgaria in achieving its national EU2020 targets and flagship initiatives:

- R&D expenditure in relation to GDP is to increase to 1.5% (2020), increasing to 31.10% of the enterprises realized innovation activities;
- The share of RES energy in gross final energy consumption to rise to 16 % (2020) and the share of energy from renewable sources in transport to reach 10%;
- Higher energy efficiency by 25% until 2020;
- Employment among the population aged 20 to 64 years 76% for 2020 (versus 63.5% in 2013): reduced level of unemployed youths aged 15-29 to 7% in 2020;

achieving employment rate among older persons (55-64 years of age) of 53% in 2020;

- Reducing the number of people living in poverty by 260 000 until 2020;
- Share of students dropping out of the educational system to decrease to 11% for 2020 (versus 12.5 % in 2013);
- Share of persons aged 30-34 with completed higher or equivalent education: 36% for 2020 (versus 29.4 % in 2013);
- Reduced time for providing administrative services with 50% compared to 2013.

Budget

Around EUR 7.57 billion has been allocated to Bulgaria for Cohesion policy for the programming period 2014-2020: EUR 3.57 billion ERDF, EUR 2.28 billion Cohesion Fund, EUR 1.52 billion ESF (of which EUR 55.2 million will be added to the), EUR 55.2 million for the Youth Employment Initiative specific allocation, and EUR 165.7 million for territorial cooperation. The amounts dedicated to social inclusion and fighting poverty are EUR 407 million (27% of the total ESF budget).

EUR 2.34 billion will be devoted to development of the agri-food sector and rural areas from the EAFRD. The allocation for the EMFF amounts to some EUR 88 million. Details on the allocation are given in a table below.

Significant attention is given to the territorial dimension of interventions in particular in the area of urban development and access to public services. Around 20% of the ERDF allocation may be invested in sustainable urban development actions implemented in Bulgaria mainly through Integrated Territorial Investments in several urban centres and their functional areas.

Programme architecture

Cohesion policy will be delivered by 7 operational programmes (OPs):

- 2 national OPs co-financed by ERDF (Operational programme "Regions in Growth", Operational programme "Innovations and Competitiveness);
- 2 national OPs co-financed by ERDF and CF (OP Environment, Operational programme "Transport and transport infrastructure");
- 1 national OP co-financed by ESF and ERDF (Operational programme "Science and education for smart growth");
- 2 national OP co-financed by ESF (OP "Good Governance" OP "Human Resources Development".

Moreover, there is a Rural Development Programme (financed by EAFRD) and a Maritime and Fisheries programme (financed by EMFF).

Details on allocations to operational programmes are presented in Table 2 below.
